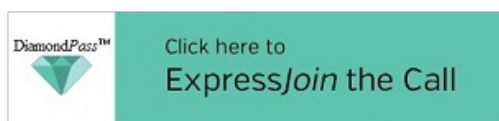
EVEREADY will be represented by senior members of the management team. The call will open with key comments, followed by an interactive Question & Answer session.
